## Terms and Conditions

- (i) Prerequisite for participation is the completed and signed entry form, the disclaimer and the transfer of the entry fee.
- (ii) The number of participants is limited to max. 60 vehicles. Starting numbers are assigned in sequence of receipt of the first payment (greyhound procedure).
- (iii) The entry fee for driver and front passenger is 800 EUR including 3 hotel nights and 2 dinners. (including non-alcoholic drinks) It is due upon registration. For additional passengers in a single room, an amount of EUR 550 per person will be charged.
- (iv) The entry fee is non-refundable. In case of cancelation of the event, partial refunding is possible.
- (v) Entry confirmations will be sent by email after receipt of the entry.
- (vi) The driver confirms to be in possession of a valid driver's license and the vehicle registration certificate valid for the participating vehicle.
- (vii) The participating vehicles are registered for use on the road. You have to have a corresponding proof of insurance and a license.
- (viii) Participation is at your own risk. Participants participate in this contest at their own risk and bear civil and criminal liability for any damage caused by you or your vehicle.
- (ix) Upon submission of the entry, the participants fully and legally bindingly accept the conditions specified for this event.
- (x) Force majeure and regulatory requirements principally release the organization from compliance with its obligations. The legal process is excluded.
- (xi) Only the official organization is entitled to binding statements.
- (xii) We kindly ask you to supply a colour photo of your vehicle as a jpg file and a short description of the history of the vehicle for publication in the program booklet with the name of the driver and co-driver.
- (xiii) By submitting the entry, the driver and passenger of the vehicle agree that pictures texts of the vehicles and registered persons may be published.

## Disclaimer

Driver and passengers declare for themselves and their relatives with the submission of the Entry Form the waiver of claims of any kind

- (i) For damages incurred in connection with the above event and in detail against the organizer, its agents, staff and possible track owners and/or spectators.
- (ii) against authorities and any persons associated with the organization of the event, unless the accident or damage is due to intent or gross negligence.
- (iii) against road workers, insofar as damage is caused by the nature of the roads and paths to be used at the events, including accessories.
- (iv) against vicarious agents and vicarious staff of all aforementioned persons and bodies, except in case of intentional or grossly negligent cause of damage.
- (v) against other participants (applicants, drivers, co-drivers), their assistants, owners, owners of other vehicles.

- (vi) In relation to their own drivers / co-drivers and their own staff, they waive claims of any kind for damages incurred in connection with participation in the event, except in cases of intentional or grossly negligent cause of damage.

This limitation of liability does not apply insofar as damages due to an insurance service are to be compensated for and rendered.
